How much is anti-dumping duty on solar glass?

In a bid to reduce imports and boost domestic manufacturing, the union ministry of finance last month imposed a provisional anti-dumping duty on textured, tempered, coated and uncoated solar glass imports from China in the range of \$673-677 per tonne and \$565 per tonne for imports from Vietnam.

Does China have an anti-dumping duty on tempered glass?

The Finance Ministry had imposed an anti-dumping duty on Chinese solar glass for five years, with effect from August 18, 2017. In May 2022, DGTR recommended extending the anti-dumping duty on imported textured tempered glass from China by two more years.

Will India impose an anti-dumping duty on solar panels?
